Joint MSPAS/MPH Student Health and Immunization Clearance Requirements

Class of 2020 Matriculation Health Requirements

Students must remain in compliance throughout enrollment within the program. Students who are not in compliance will be removed from classes and/or clinical rotation(s) until such time as the deficiency is corrected. No exceptions will be made.

****Please note: All documentation must be provided to Touro University California Student Health Office. Additionally, students must provide an additional copy of all documentation regarding communicable disease clearance (Forms D-F and copies of laboratory titers) to the PA program separately. ****

Class of 2020 Matriculation Health Requirements

1. Measles

Submit documentation of a positive **quantitative** antibody titer administered **within the past 5 years** (lab report or physician verification required). If titer is negative or equivocal, a new alert will be created for you to repeat the 2 dose series and submit a repeat titer. If series is in process, submit where you are and a new alert will be created for you to complete the 2 dose series and titer. **Photos are NOT acceptable.**

2. Mumps

Submit documentation of a positive **quantitative** antibody titer administered **within the past 5 years** (lab report or physician verification required). If titer is negative or equivocal, a new alert will be created for you to repeat the 2 dose series and submit a repeat titer. If series is in process, submit where you are and a new alert will be created for you to complete the 2 dose series and titer. **Photos are NOT acceptable.**

3. Rubella

Submit documentation of a positive **quantitative** antibody titer administered **within the past 5 years** (lab report or physician verification required). If titer is negative or equivocal, a new alert will be created for you to repeat the 2 dose series and submit a repeat titer. If series is in process, submit where you are and a new alert will be created for you to complete the 2 dose series and titer. **Photos are NOT acceptable.**

4. Varicella (Chicken Pox)

Submit documentation of a positive **quantitative** antibody titer administered **within the past 5 years** (lab report or physician verification required). If titer is negative or equivocal, a new alert will be created for you to repeat the 2 dose series and submit a repeat titer. If series is in process, submit where you are and a new alert will be created for you to complete the 2 dose series and titer. **Photos are NOT acceptable.**

5. Hepatitis B

Submit documentation of a positive **quantitative** antibody titer administered **within the past 5 years** (lab report or physician verification required). If titer is negative or equivocal, new alerts will be created for you to repeat the 3 dose series and submit a repeat titer. If series is in process, submit where you are and a new alert will be created for you to complete the 3 dose series and submit a titer. **Photos are NOT acceptable.**

6. Tuberculosis (TB)

Submit documentation of one of the following administered within the past 12 months:

- Negative two-step skin test administered 1-3 weeks apart OR
- Two negative single step tests within the past 12 months OR
- If positive, submit ALL of the following:
 - Documentation of the past positive skin test AND
 - Clear chest x-ray report AND
 - TUC Form C – TB Symptom Survey available at <http://studentservices.tu.edu/studenthealth/forms.html> AND
 - Documentation of one of the following:
 - INH treatment OR
 - A subsequent negative IGRA blood test OR
 - Documentation from a medical provider (i.e., PA/NP/MD/DO) that treatment is not warranted

Renewal will be set to 1 year. Upon renewal, submit one of the following:

- Negative one-step skin test (as long as the last skin test was <12 months prior) OR
- Negative two-step skin test administered 1-3 weeks apart OR
- Two negative single step tests within the past 12 months OR
- If positive, submit all of the following:
 - Documentation of the positive skin test (if not provided previously) AND
 - TUC Form C – TB Symptom Survey available at <http://studentservices.tu.edu/studenthealth/forms.html> AND
 - A clear chest x-ray report
 - Chest x-ray MUST be performed between January 1 – February 14 of the second school year
 - INH treatment OR
 - A subsequent negative IGRA blood test OR
 - Documentation from a medical provider (i.e., PA/NP/MD/DO) that treatment is not warranted

Photos are NOT acceptable.

TB skin test results must be read within 48 to 72 hours of placement and must be recorded in mm of induration. All Documentation must be submitted on the forms available to download from this requirement, by selecting the blue "TB Reporting Forms" link below.

7. Tetanus, Diphtheria, & Pertussis (Tdap)

Submit documentation of a Tdap booster administered within the last 10 years. You must remain current with either Tdap or Td during your enrollment at Touro (within 10 years). **Photos are NOT acceptable.**

8. Polio

Do you have documentation of your primary series for polio (at least three vaccinations)?

- If **yes**, submit your vaccine series.
- If **no**, this requirement will be marked completed.

9. Influenza

Please submit documentation of a flu shot administered during the flu season that begins the year of matriculation (September-May). Documentation must indicate that the vaccination you received is from a batch for the current flu season. The due date is **November 15** in the incoming year. You will not be able to get this vaccine until after matriculation, when the vaccine becomes available in September or October. Renewal date will be set to **November 15** of the following flu season. **Photos are NOT acceptable.**

10. Physical Examination

Submit your physical exam form completed and signed by a medical professional within the past 12 months on the 2 page school form. The renewal date will be set to January 1 of the second school year. Renewal must be **performed** between the dates of January 1 – February 14. **Photos are NOT acceptable.**

11. Childhood and Additional Vaccination Records

Do you have documentation of any additional vaccinations that you wish to submit? If "yes", submit additional vaccinations. If "no", this requirement will be marked complete. **Photos are NOT acceptable.**

12. Form A: Student Information

Download, print, sign, scan and upload the Form A: Student Information document that is available from this requirement. **Photos are NOT acceptable.**

13. Form F: Consent for Student Health to maintain health information and release of Information to Clinical Rotations

Download, print, sign, scan and upload the Form F: Consent for Student Health to maintain health information and release of Information to Clinical Rotations document that is available to download from this requirement. **Photos are NOT acceptable.**

14. Health Insurance

This is not required for matriculation. All students are required to have Health Insurance that complies with Touro requirements. You may sign up for the Student Health Insurance Plan or use your personal Touro-compliant Health Insurance. You must submit documentation of your current health insurance card OR proof of coverage by October 1. Both sides of insurance card are required. **Photos are NOT acceptable.**
